- The 'O' Judges Register is for TSR affiliated shows and unaffiliated shows to use, judges on the 'O' register are not eligible to judge HOYS qualifiers.
- BSHA, Sport Horse (GB) judges may be eligible to judge Plaited Pony Classes on the TSR 'O' Register.
- Existing panel judges on Sport Horse (GB), British Show Horse, BSPS, NPS, CHAPS, NCPA, BSPA, SSADL, SWPA MAY be
  appointed to the equivalent panel on the TSR 'O' Register upon approval. Judges with 3 years or less experience on a
  panel may be asked for extra supporting evidence or an appraisal.
- Judges applying for RIDE will be asked to go for a RIDE Assessment unless they are already a panel ride judge.
- We advise you only apply for one type of panel i.e. ponies, horses or M&M NOT all panels.
