

# The Showing REGISTER

## GENERAL – SITE

- All attendees must respect the other users of Stoneleigh Park – including adhering to the speed restrictions of site.
- The hire is strictly for the user of the Equestrian All-Weather Arena; there is **NO** hacking around site or using other areas – any user found not adhering to this will be asked to leave site immediately.
- There are strict No dogs allowed in the arena.
- Dogs must be kept on leads at all times when on Stoneleigh Park.
- Riders must be accompanied by an adult over 18, either on foot or mounted.
- Users must thoroughly poo pick after using the facilities, including the car parks – tools are provided.
- Parking is on the allocated hard standing car park only. **NO** parking on the grass.
- **NO** mucking out lorries or trailers on site.
- Toilet facilities will be open for you to use during the hire; facilities must be left as they are found.

## SAFETY EQUIPMENT

- Riding hats that adhere to the current BE safety standards, with no fixed peak must be worn.
- Body protectors that adhere to the current BE safety standards **must** be worn.
- Failure to wear correct safety equipment will void any insurance and result the rider being ejected from the facility.

## BEHAVIOUR

- Riders and their companies must co-operate with the others using the facility.
- Bad behaviour or language towards staff and other users will strictly not be tolerated and will result in the user asked to leave site immediately and may result a ban in using the facilities in the future.
- Riders must ride within their capabilities and observe their surroundings accordingly.

## FACILITIES TERMS AND CONDITIONS, PRIVACY POLICY

- All data provided is kept by the Grandstand Group in their secure database.
- Data is held for users to make re-bookings more straight forward and to enable is to contact you in an emergency.
- Grandstand Group do not share data or allow access to the data to any third parties.
